RELEASE AND ASSUMPTION OF RISK FORM**

The undersigned hereby acknowledges that participation in any of the Sport Club activities at Dalhousie University is purely voluntary and is not part of the academic curriculum of the University. In consideration of the University making any equipment and/or facilities available to said club and/or the undersigned while participating in any such activities, the undersigned hereby releases and will indemnify and save harmless Dalhousie University, its successors, officers, agents, and employees from any and all claims, demands, and causes of action whatsoever in any way growing out of or resulting from the participation by the undersigned in the activities of the said Sport Club.

The undersigned further agrees and acknowledges that many of the activities of said Sport Club may involve substantial risk of serious bodily injury, property damage and other damages to participants and to third persons arising out of participation therein, and the undersigned expressly assumes the risk of such injury or damages as a personal risk of participation, including injury or death caused from an automobile accident while on a club trip or in route to a club event. It is expressly understood by the undersigned that he/she is solely responsible for any losses or damages sustained by the undersigned or by any third person because of bodily injury or property damage sustained as a result of participation by the undersigned in normal or unusual activities of the said Sport Club. (The undersigned is encouraged to obtain adequate hospital/medical and liability insurance coverage).

The undersigned also acknowledges that while travelling to / from club activities or competitions that he/she is covered by personal insurance (i.e. health, auto, etc.) and not by any Dalhousie insurance policies.

If the undersigned is a minor, the signature of a parent or guardian appearing in the space indicated below signifies acceptance by said parent or guardian that the terms and conditions hereof shall be binding upon them and shall constitute a release by them of any and all claims, demands and causes of action whatsoever which they may have against Dalhousie University, its successors, officers, agents or employees as a result of participation by the undersigned in the activities of said Sport Club.
